4. Kindergarten change in hours, increase student day by 30 minutes

Uncertified STAR test scores: 16% PROF/ADV 2nd grade discussed by Nathan & Louthea. Developmental approach - No symbols in Kinder or 1st grade, challenges, 2/3 learn to read no matter what, the other 1/3 need specific instruction that varies discussed by Jeff & Laurie. Assessment of Kinder & 1st grade Developmental milestones; 2nd grade Basic Phonics and Rigby Assessment, QRI 4th and up.

Reading Instruction explanation from Laurie including a description of Lindamood-Bell Training.

Laurie states STAR test is less informative - keep assessment for every child. STAR Test not used as a diagnostic tool until 4th grade, 2nd grade intervention is crucial, but not a key indicator according to Laurie. Rigby being used to assess and trigger intervention.

Laurie feels the Kinder Teachers will make a better connection to parents & that it is more important than reading - there is a 3 year plan to improve our Kinder Program.

Louthea questioned why 2 hours and 15 minutes is insufficient planning time. Susan explained what is done during that time (dishes, garden watering, etc.) Louthea asked if these duties could be performed by volunteers and janitorial staff. Schedule is questioned and clarified by Sheila and Susan.
