Re: Your complaint dated October 3, 2022 regarding past alleged Brown Act Violations

To Kristina Miller:

The Blue Oak Charter School Charter Council has received what we read to be a cease and desist request dated October 3, 2022<sup>1</sup> alleging that the following described past actions of the legislative body violate the Ralph M. Brown Act:

That the Charter Council met on 18 occasions in closed session from 2/16/21 through 9/10/22 to discuss the potential purchase of real property in a manner that was not adequately noticed, disclosed, and agendaized for each applicable meeting in compliance with Government Code Sections 54956.8 and 54954.5(b).

In order to avoid unnecessary litigation and without admitting any violation of the Ralph M. Brown Act, the Blue Oak Charter School Charter Council hereby unconditionally commits that it will cease, desist from, and not repeat the challenged past action as described above.

The Blue Oak Charter School Charter Council may rescind this commitment only by a majority vote of its membership taken in open session at a regular meeting and noticed on its posted agenda as "Rescission of Brown Act Commitment." You will be provided with written notice, sent by any means or media you provide in response to this message, to whatever address or addresses you specify, of any intention to consider rescinding this commitment at least 30 days before any such regular meeting. In the event that this commitment is rescinded, you will have the right to commence legal action pursuant to subdivision (a) of Section 54960 of the Government Code. That notice will be delivered to you by the same means as this commitment, or may be mailed to an address that you have designated in writing.
