➤ This month's financial outlook is similar to last month. The hold harmless funds have been certified by the state; the initial amount that was certified by the audit is going to be paid as requested. We won't see it in one lump sum but all of that money will be received eventually in different installments. We also have an additional grant that was approved last week. Cash is running low; we knew this would happen but with the expense trend growing, it is putting more pressure on cash than expected. The overall outlook on cash at this point is okay but as we near May/June we may return to concerns about cash flow so we need to keep an eye on that. The cash stress point comes from an increase in expenses over the summer but a slow down in receipts from funds received. We are still using a number of one-time grants to get us through the deficit this year unless otherwise decided by the council. Our over expenditures are about \$60K and mostly include compensation costs.

- Account information: Your name and account number. - Dollar amount: The dollar amount of the suspected error.

- Description of Problem: Describe what you believe is wrong and why you believe it is a mistake.

You must contact us:

- Within 60 days after the error appeared on your statement.

- At least 2 business days before an automated payment is scheduled, if you want to stop payment on the amount you think is wrong.

You must notify us of any potential errors in writing. You may call us, but if you do we may not follow these procedures and you may have to pay the amount in question.

What Will Happen After We Receive Your Letter

When we receive your letter, we will do two things:

1. Within 30 days of receiving your letter, we will tell you that we received your letter. We will also tell you if we have already corrected the error. 2. We will investigate your inquiry and will either correct the error or explain to you why we believe the bill is correct.

While we investigate whether or not there has been an error: We will not try to collect the amount in question.

- The charge in question may remain on your statement, and we may

continue to charge you interest on that amount. While you do not have to pay the amount in question, you are responsible for the remainder of your balance.

- We can apply any unpaid amount against your credit limit.

After we finish our investigation, one of two things will happen:

- If we made a mistake: You will not have to pay the amount in question or any interest or other fees related to that amount.

- If we do not believe there was a mistake: You will have to pay the amount in question, along with applicable interest and fees. We will send you a report you as delinquent if you do not pay the amount we think you owe.
