4.1. Tour Results

Facilities Tour Notes 10/16/23 and 11/2/23

Site #1 - Fair St. @ Hwy 99 - Bill Chance (Broker) showed us the 22 acres (will not parcel) property. Front 6 acres is what is really usable for building. Soil investigation done and no contamination since it has never been built on. Is in a flood zone so there is a mitigation plan already provided. City of Chico will be building a frontage road with access from Hwy 99. It is a big property with lots of natural beauty (wild elderberry bushes). There is freeway noise.

Site #2 - Concord Ave & E. 20th St. (Miriam Park) - John Carter and Brian from Miriam Park, Candace (realtor) from C21 and Ross from North Star (engineer) showed us 2.47 acres of usable space (sidewalks and street is already in) there are plans already for a public park on the other side of the property that will be run by CARD. Zoned non commercial. There is only one in/out to the property. Could be too small of a space. Very quiet and beautiful neighborhood. Feels like a perfect spot for a school based on location and future building plans. **11/2/23** - Met with Dan Gonzalvez and John Carter from Miriam Park, Candace from C21. Dan believes in Charter schools and wants a school there. He wants to work with us and the local tribe to have input on the public park next to the site. The land is "shovel ready" and they will give consulting for free on a limited basis that will save us a lot in choosing subs and navigating the red tape if necessary.

Site #3 - 2080 E. 20th St. (United Health Care building) - Kat M. gave her impressions. It is a better made building than what we are currently in. She thought it was a good location. It does feel like the same as what we are in now and would take a lot of imagination and planning to renovate to our needs. Very interested in finding out how high the ceilings go up.
