Blue Oak Charter School ("Blue Oak" or the "Charter School") is a tuition-free Waldorf-inspired, T/K-8, public school that opened in September of 2000 with seventeen children and one teacher. Today the school supports approximately 240 children and 40 employees and represents families all over Butte County. At Blue Oak, our priority is to provide an education that excites and interests the students. Our Waldorf-inspired/Common Core-based curriculum helps develop a lifelong love of learning, and prepares each child for active & ethical citizenship; critical thinking, self-awareness, creative imagination, & social responsibility. The curriculum is molded by each teacher to address the individual and developmentally appropriate needs of the class. Science and Social Studies are interconnected with English, Math, art, music, and movement through storytelling. Transitional Kindergarten is folded into our Kindergarten which is play-based and helps students develop positive relationships preparing them for the more academic work of the first grade and beyond. Classes loop, staying together with their teacher for first through eighth grade. This increases the teacher's understanding of each student's needs and builds the strength of relationships that last into high school and beyond. Specialty subjects include language, music, handwork, technology, & games.

Reflections: Annual Performance

The California Dashboard shows Blue Oak needs continued work on Chronic Absenteeism and Suspension rates. Though overall Chronic Absenteeism has improved, it is still at 35.4% for all students. Students with Disabilities and Hispanic students show 47.4% and 37.7%, respectively. Math and ELA scores are also a concern, but not at the same dramatic level. Work to improve ELA and math instruction is also needed.

Reflections: Technical Assistance

Blue Oak Leadership Team, comprised of teachers, the counselor, and the administration, met in four sessions with the Butte County Office of Education's Differentiated Assistance team for technical assistance during the Spring of 2024. The sessions reviewed team perceptions and evaluated data to establish areas needing strengthening and increased attention. That work is reflected in this document.

Educational partners expressed the need for support for students who are not engaged, adopting SEL initiatives, addressing chronic absenteeism and suspensions, and fostering strong relationships with low-income families. The LCAP includes actions to address these needs, such as SEL services and training, conducting home visits, providing support for at-risk students and families, and implementing restorative practices.

Feedback also influenced the goals for ELA, including providing summer school and after-school programs, increasing collaboration time for teachers, and focusing more on family engagement. The LCAP process was updated based on feedback, including using a Plan-Do-Study-Act process and displaying metric data in a disaggregated manner. The feedback from educational partners informed decisions on increasing or improving services for unduplicated student groups. The LCAP includes a focus on school connectedness, attendance, suspension rates, and literacy and language proficiency. The engagement process and feedback from educational partners were integrated into the goals and aspects of the LCAP.
