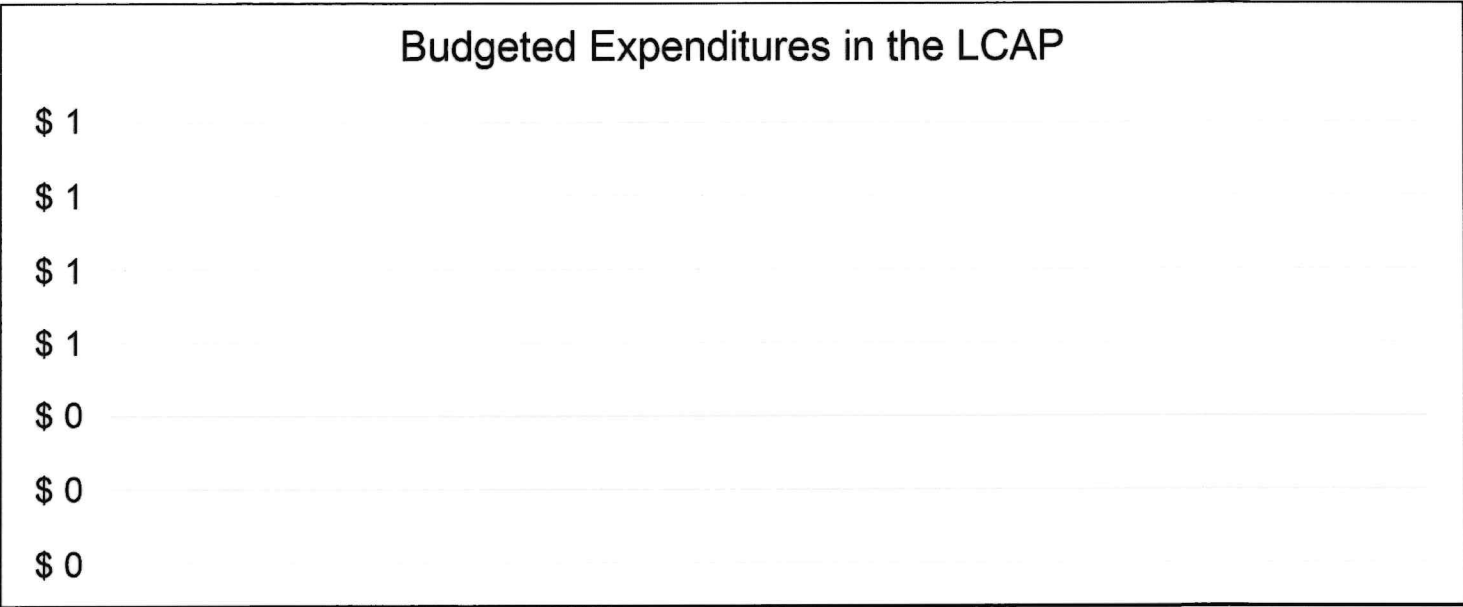

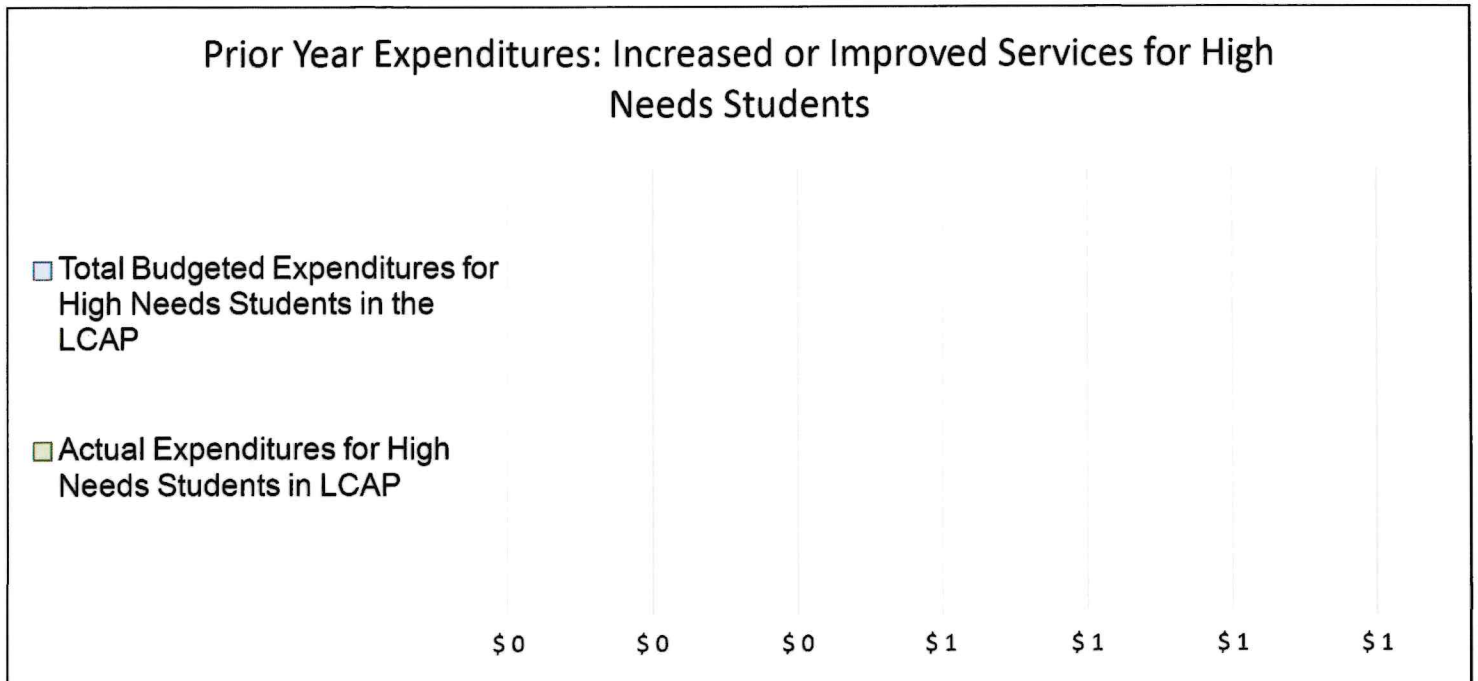

## Plan Summary [2025-26]

### General Information

**Vision:** To be a model for successful education of the whole child.

**Mission:** To nurture and deepen each child's academic and creative capacities using methods inspired by Waldorf education in a public school setting.

Blue Oak Charter School ("Blue Oak" or the "Charter School") is a tuition-free Waldorf-inspired, T/K-8, public school that opened in September of 2000 with seventeen children and one teacher. Today the school supports approximately 240 children and 40 employees and represents families all over Butte County. At Blue Oak, our priority is to provide an education that excites and interests the students. Our Waldorf-inspired/Common Core-based curriculum helps develop a lifelong love of learning, and prepares each child for active & ethical citizenship; critical thinking, self-awareness, creative imagination, & social responsibility. The curriculum is molded by each teacher to address the individual and developmentally appropriate needs of the class. Science and Social Studies are interconnected with English, Math, art, music, and movement through storytelling. Transitional Kindergarten is folded into our Kindergarten which is play-based and helps students develop positive relationships preparing them for the more academic work of the first grade and beyond. Classes loop, staying together with their teacher for first through eighth grade. This increases the teacher's understanding of each student's needs and builds the strength of relationships that last into high school and beyond. Specialty subjects include language, music, handwork, technology, & games.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

The California Dashboard shows Blue Oak needs continued work on Chronic Absenteeism and Suspension rates. Though overall Chronic Absenteeism has improved, it is still at 35.4% for all students. Students with Disabilities and Hispanic students show 47.4% and 37.7%, respectively. Math and ELA scores are also a concern, but not at the same dramatic level. Work to improve ELA and math instruction is also needed.

Reflections: Technical Assistance

Blue Oak Leadership Team, comprised of teachers, the counselor, and the administration, met in four sessions with the Butte County Office of Education's Differentiated Assistance team for technical assistance during the Spring of 2024. The sessions reviewed team perceptions and evaluated data to establish areas needing strengthening and increased attention. That work is reflected in this document.

We believe that educational partners play a key role in identifying local needs, possible actions to address such needs, and in supporting improved student outcomes. For this reason, we strive to engage all educational partners in the process of developing and annually updating the LCAP. Additionally, we collaborate with our educational partners in a process of continual improvement utilizing plan-do-study-act cycles, meaningful engagement, and shared decision making in support of student success. The process of engaging educational partners in the development of the LCAP included revising the engagement process based on feedback and conducting various activities to gather input. Educational partners expressed the need for support for students who are not engaged, adopting SEL initiatives, addressing chronic absenteeism and suspensions, and fostering strong relationships with low-income families. The LCAP includes actions to address these needs, such as SEL services and training, conducting home visits, providing support for at-risk students and families, and implementing restorative practices.
	Conducted a walkthrough meeting to promote educational partner participation in consultation opportunities. ParentSquare announcements were sent to all staff and family members. Families were sent text messages and emails through the student information portal. Students were informed on site. Additionally, the community was notified through the district's Facebook page. Held "Donuts with the Director" onsite to provide educational partners with an

	opportunity to provide school leadership with input that informs the LCAP development process. Hosted Teen Talk after school program and conducted student interviews for the upper grades. Met with members of student advisory committees/leadership groups to request feedback. This includes, but is not limited to, asking them to help identify student needs as well as actions to address the identified needs.
	Surveyed staff, families, and students separately to request input related to student needs, possible actions to address needs, and potential updates to the LCAP. Conducted input gathering sessions at staff meetings to review and analyze local and state-level data, determine root causes, understand site-level needs, as well as options to address needs.

Feedback also influenced the goals for ELA, including providing summer school and after-school programs, increasing collaboration time for teachers, and focusing more on family engagement. The LCAP process was updated based on feedback, including using a Plan-Do-Study-Act process and displaying metric data in a disaggregated manner. The feedback from educational partners informed decisions on increasing or improving services for unduplicated student groups. The LCAP includes a focus on school connectedness, attendance, suspension rates, and literacy and language proficiency. The engagement process and feedback from educational partners were integrated into the goals and aspects of the LCAP.

## Introduction and Instructions

The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- **Comprehensive Strategic Planning:** The process of developing and annually updating the LCAP supports comprehensive strategic planning, particularly to address and reduce disparities in opportunities and outcomes between student groups indicated by the California School Dashboard (California Education Code [EC] Section 52064[e](1)). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data.
