We are exploring different ways to provide dance ceramics, ukelele's eurythmy theater etc. We are also looking at bringing music lessons to lower grades. We are looking at an exemption for what we can use the money on. Since we are under 500 students we might be able to use the funding for programs already in place. 1% can be used for overhead. This is a proposition, which is funded by the citizens of California so the citizens would have to vote to take this funding away. The amount received may vary but this is a pretty secure funding that we can expect will continue. If we don't use it we lose it.
